BACKGROUND / EXPLANATION OF IMPACT

An internal audit was performed by staff to compare District account information with Whatcom County Assessor's records.

Summary of Analysis:

- County Assessor's data published January 26, 2012 was utilized for the study.
- Developed parcels were selected from the assessor's data where the appraised property improvements are greater than \$20,000.
- The District account database was compared to the developed parcel list. Developed parcels that did not have either a water or sewer account were reviewed individually. GIS was used to visually see where the missing water/sewer account parcels were located.

Summary of Results:

- Water Accounts. 14 parcels were flagged for review. None of the parcels turned out to be using District water without a District meter and billing account. Most were sewer-only customers along Lake Whatcom Boulevard. Several accounts needed minor data updates to be properly selected in the District account query. The remaining were homes still under construction that have not yet requested water to be turned on.
- Sewer Accounts. 15 parcels were flagged for review. Two parcels appear to be served by sewer and are not being billed. One parcel appears to have an accessory dwelling unit in addition to the main house and should be charged for 2 equivalent residential units (ERU). One parcel is across the road from a sewer main, is not hooked up to sewer, but should be per District policies. The remaining parcels were still under construction or had inconsistencies with site address between the District account database and the County Assessor database.

Staff will follow up with the 4 parcels identified with sewer billing issues.

BACKGROUND / EXPLANATION OF IMPACT

Sudden Valley Community Association (SVCA) is scheduled to begin work on replacing a failing culvert on Polo Park Drive with a new bridge in Division 8 between Lots 121 and 122. There is an 8-inch District water main that runs under the culvert and needs to be relocated and attached to the new bridge. SVCA has contracted with a contractor for bridge construction. SVCA is a private organization and is not required to follow public works contracting law.

The District's public water main relocation work will be done by separate public works contract. On July 16th, 2012 contactors on the District's small works roster were sent an Advertisement for Bids. Bids are due on July 31st, 2012.

The construction window in the creek is very tight due to environmental restrictions. Staff requests that the Board authorize the General Manager to award and execute a contract with the lowest responsible bidder following the July 31st bid opening with a not to exceed contract amount (including sales tax) of \$35,000. Waiting for Board approval at the August 8th meeting could delay SVCA's project.

Wilson's cost estimate is \$30,000 and includes a 15% contingency plus a healthy budget for traffic flagging. Flagging costs might be reduced some if the road is completely closed for construction of the bridge.

FISCAL IMPACT

2012 Budget includes \$30,000 for the construction contract.
