The Agenda topics have not been set as of this date. Remember, all Policy Group Meetings are publicly noticed by the District.
 - Management Meeting: A meeting has been set for July 8, 2013 between 3:00 p.m. and 4:30 p.m. at the District Office. Again, this involves the Mayor, the County Executive, and the General Manager. A meeting agenda has not been set yet.
- Next Regular Board Meeting: Scheduled for Wednesday, July 10, 2013 at 6:30 p.m.
- Next Employee Staff Meeting: Is scheduled for Thursday, July11, 2013 at 8:00 a.m. in the Board Room. Commissioner Millar is scheduled to attend this meeting. Scheduling is rotated by alphabetical order each month.

 WASWD Executive Director's Visit: Reminder: WASWD Executive Director Blair Burroughs's visit with the Board has been rescheduled from June 12, 2013 to July 10, 2013.

- <u>COB WWTP Contract Negotiations</u>: As mentioned previously this effort is still
 ongoing. However, I can report that we have been meeting every week in order
 to keep things going. Discussions have been very productive. We are continuing
 to meet once a week and should have something to report on soon. District staff
 briefly met before a City Council policy committee on Monday, July 17, 2013 to
 lend support to our joint efforts. It was a quick update.
- Up Coming Rate Study Update: The upcoming rate study conducted by FCSG will begin in July. Again, the Board will be updated on its status as we move along. You questions and requests raised earlier will be considered in this process.
- Updating District Personnel Policies Manual/Penalty Fees: As mentioned earlier
 I have been engaged in the tedious process of syncing up the language from the
 most recently approved labor contract and our personnel manual. There should
 never be any conflicts between the two documents. You will be seeing this
 updated document in the near future after we have completed our work and the
 Union has had a chance to look at everything.
- Updating the District's Master Fees and Charges Schedule Add Penalty Fees
 We will now complete the process of updating the Master Fees and Charges
 Schedule section of our Administrative Code that addresses penalties for code
 violations. We waited to address this issue until the sewer connection audit was
 completed.
- Annual Summer Picnic Sponsored by the Union: The bargaining unit will be sponsoring a summer picnic for the staff. Both the Board and management staff has been invited to attend. This will be held on August 15, 2013 between 12:00 noon and 1:00 p.m. The location will either be at the District Office or the Maintenance Building. The location has not been determined yet. As always we are grateful for their generosity.
