- Meetings Associated with the Lake Whatcom Management Program:
 - Policy Group Meeting: Reminder, the next meeting is set for February 25, 2015 at 6:30 p.m. in the Bellingham City Council Chambers. This is a regular meeting of the Policy Group, but it is being held in the early evening as a public hearing in order to present the draft updated five Year Lake Whatcom plan. Commissioner Mc Roberts is our Board's representative, but anyone is welcome to attend. Remember, all Policy Group Meetings are publicly noticed by the District.
 - Management Meeting: The last meeting held with the Mayor and County was on Wednesday, February 11, 2015 at City Hall. We reviewed with City and County staff the draft Lake Whatcom Management Program 2015 2019 Work Plan. This is the proposed 5-year Lake Whatcom Plan update. This is the document that will be discussed at the February 25 evening Policy Group meeting mentioned above.
