

BACKGROUND / EXPLANATION OF IMPACT

This capital improvement project retrofits existing Smith & Loveless wet well mounted pumps with new submersible pumps, controls, telemetry, and retaining wall at the Strawberry Point Sewer Pump Station on Lake Whatcom Boulevard. RH2 Engineering, Inc. is the consultant for the project.

An Advertisement for Bids was published in the Bellingham Herald and Seattle Daily Journal of Commerce on 5/1/2015. A non-mandatory pre-bid meetings was held on 5/13/2015. Two (2) bids were received and opened on 5/19/2015.

FISCAL IMPACT

Total project funding allocated in the approved 2015 capital improvement budget for this project is \$723,411.

The engineer's estimate for construction was \$405k. The low bid was \$537k and the second low bid was \$619k. *Note: Construction costs include state sales tax.*

The low bid is \$132k (33%) more than the engineer's estimate.

RECOMMENDED BOARD ACTION

The two bids received were significantly more than the engineer's estimate by 33% and 52%.

The high bid prices were due to temporary shoring installation costs being more than expected, the time of year the project was bid, and likely an economic upswing in the local construction industry (contractors are busy and already have worked lined up for the summer).

Higher bids prices can be mitigated by minor revisions to the design and re-bidding next winter. Minor value engineering design revisions can eliminate the necessity of temporary shoring and PSE temporarily de-energizing overhead power lines (a savings of around \$95k to \$105k based on bid prices received). Re-advertising the project during the winter of 2016 will likely result in more bidders and better competition for the work.

District staff believes the existing pump station can be safely maintained and operated for another year while the project design is refined.

PROPOSED MOTION

Reject all bids received, direct staff to make value engineering revisions to the design and re-bid the project during the winter of 2016.
