## **Action Taken**

Casey moved, Ford seconded, approval of:

- Accounts Payable Vouchers totaling \$62,161.94
   Motion passed.
- <u>Water Comprehensive Plan.— Service Area Boundary Review</u>
  Dave Olson from Water District #7 spoke to the Board about service area boundary issues and the possibility of selling water to District #7. The Board discussed aspects of providing wholesale water to District #7 and requested that staff provide more information at a future meeting. The District's water rights were also a topic of discussion.
- <u>North Shore Water System Consolidation</u>
   The Board discussed preparations and provided staff direction regarding the special public meeting on June 20, 2017 at 6:30 p.m.
- Administrative Assistant Position Description and Salary Range
  Sorensen explained that the current Administrative Assistant has given notice that she will be retiring effective July 28, 2017. In light of this transition, I have taken the opportunity to reevaluate and amend the existing position description and salary range. Presently the position is listed and budgeted as Pay Grade 9. Because of the position description modifications I am proposing that the Pay Grade be lowered to Pay Grade 6; a 15% reduction from the existing salary. The Board discussed the amended position description and salary range and requested one minor change to the position description.
